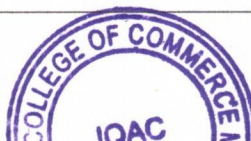

Formation of NCC/NSS Units:</p> <p>Following the recommendations from the NAAC visit, the college explored the possibility of establishing NCC (National Cadet Corps) or NSS (National Service Scheme) units. Aparna Matekar was deputed to inquire about the formation and requirements of these units. Upon investigation, it was found that our institution could not form NCC or NSS units due to our small size. Both units require a minimum of 100 student volunteers, which our institution currently does not meet.</p> <p>2. Faculty Development:</p> <p>In response to the NAAC visit, two faculty members have enrolled for their PhDs, showing our commitment to continuous professional development and academic excellence. Additionally, one faculty member is currently awaiting the viva voce for their PhD, marking a significant milestone in their academic journey.</p> <p>3. Faculty Exchange Programs (FEP):</p> <p>To further enhance faculty development and collaboration, the college has initiated two Faculty Exchange Programs (FEP) with Chandrabhan Sharma College. This initiative, formalized through a Memorandum of Understanding, aims to foster academic exchange and professional growth for our faculty members.</p>
